A. Welcome and Introductions

Kizz Prusia, Land Use Program Lead, welcomed LUTAC members to the February 11 meeting. He reviewed the meeting objectives and topics. He also noted that at the start of the year the KRCC Board Chair and Vice-Chair elected to focus more specifically on land use and transportation issues. Both the Chair and Vice-Chair will attend LUTAC and TransTAC meetings respectively throughout the year.

B. Old Business

Meeting Summary Review: LUTAC members reviewed the January 14 meeting summary. There were no comments provided and the summary was approved to be posted on the KRCC website.

C. Committee Updates and Work in Progress

Kitsap Countywide Planning Policies (CPPs) Schedule Update: Clay White, LDC Inc., reviewed project updates. This included project schedule, project milestones, and updates on other KRCC meetings. He explained the project schedule is on track based on plans for the KRCC Board to vote to adopt the Kitsap CPPs in June 2021. He also noted that updates have been provided to TransTAC, PlanPOL, and the KRCC Board on the status of the Kitsap CPPs.

Kitsap Countywide Planning Policies (CPPs) Draft Policy Review: Clay led a review of twenty draft policies with a focus on newly added language and policies that garnered the most comments. LUTAC members were asked to provide input on draft policy language while considering if there were any other needs for these draft policies and if the policy intent was clear.

Clay live-edited the draft policies with revisions and suggestions from LUTAC members. LUTAC members expressed the following concerns with draft policy language:

- Element B: Urban Growth Areas (UGAs): Several members suggested the proposed criteria for expanding UGAs needs to explain the UGA process and reference county UGA boundaries. Several members also suggested UGA expansion should not occur within rural areas. One LUTAC member requested changes to UGA policy 3, subsection H.
- Element D: Rural Land Uses: Several members noted the use of the terms "rural centers" and "rural communities". These LUTAC members requested that if "rural centers" be kept in the CPPs the term be consistently used throughout the entire draft document.

LUTAC did not complete a review of Element B and Element D during the February 11 meeting. Members recommended revisiting several sections of the Kitsap Countywide Planning Policies (CPPs) including Elements B and D referenced above during another LUTAC meeting.

D. New Business

Kitsap CPPs Growth Targets: KRCC staff briefly shared that the KRCC Board approved expanding LDC Inc.'s contract to include growth target work.

E. Administrative Agenda

March 16 PlanPOL Meeting: LUTAC members discussed the next PlanPOL meeting and what materials need to be included in the CPP briefing. Members recommended scheduling two subcommittee meetings to address draft policy language not reviewed prior to the March 16 PlanPOL meeting.

KRCC staff scheduled a sub-committee meeting with LUTAC members on February 17 to continue discussing the next steps for updates to Element B: Urban Growth Areas, Element D: Rural Land Uses, Element I: Housing, and Element J: Countywide Economic Development.

A. Welcome and Introductions

Kizz Prusia, KRCC Land Use Program Lead, welcomed participants and provided a recap of the February 11 meeting and noted Element C: Centers of Growth was being developed by Karla Boughton, City of Poulsbo, and Element G: Capital Facilities and Element H: Transportation were being reviewed by TransTAC. He explained updated versions of Element G and Element H will be available to discuss during the March 11 LUTAC meeting.

B. Committee Updates and Work in Progress

Kitsap Countywide Planning Policies (CPPs) Draft Policy Review: Clay led a review of ten draft policies with a focus on policies that were not reviewed during the previous meeting. LUTAC members provided the following feedback:

Review of Element B: Urban Growth Areas (UGAs)

UGA-3. Process and criteria to ensure regional coordination when establishing, expanding, and adjusting Urban Growth Areas in Kitsap County:

- Several LUTAC members commented on the process for applying for UGA expansion. These
 members noted the current draft policy language did not account for the docket request
 process. LUTAC members suggested this policy cite the Growth Management Act (GMA)
 36.70a.110 and associated Washington Administrative Code (WAC) 365.196.325.
- Several LUTAC members commented on the expansion of an individual UGA boundary that
 results in a net increase of residential, commercial, or industrial land. These members
 suggested removal of UGA-3 sub policies H3-5. LUTAC members also suggested revising the
 original language and proposed language to be consistent with GMA 36.70a.110 and the
 WAC 365.
- LUTAC members are discussed coordination between cities and the county. LUTAC members
 noted the draft Kitsap CPPs contain language about coordination and Interlocal Agreements
 (ILAs) and it might be worth looking at addtl language and reiterate in the UGA policies
 coordination.

Review of Element D: Rural Land Uses

R-2 Preserving Rural Land Use and Development Patterns, A: Rural Centers:

 One LUTAC member suggested to add detail regarding how rural centers are characterized based on what existing services they may have. R-2 Preserving Rural Land Use and Development Patterns, B: Rural Communities:

• LUTAC members discussed the difference between the term "rural centers" and "rural communities". LUTAC members reached agreement on maintaining both terms in the draft Kitsap CPPs. LUTAC members also agreed to the suggestion of updating denoting whether a center was urban or rural throughout the entire document.

Review of Element I: Housing

AH-1. Coordinated process among County, Cities, and housing agencies for determining and fulfilling housing needs, and the equitable distribution of affordable housing at all income levels in Kitsap County:

• Several LUTAC members expressed concern with the area median income (AMI) listed in the introduction to this element.

AH-2. Recognizing that the marketplace makes adequate provision for those in the upper economic brackets, each jurisdiction should develop some combination of appropriately zoned land, regulatory incentives, financial subsidies, and/or innovative planning techniques to make adequate provisions for the needs of middle- and lower-income persons:

• Several LUTAC members suggested it may add value to define the term "missing middle in the document.

AH-3. Recognizing the percentage share of the existing and forecasted countywide population and housing stock, as well as the distribution of existing housing for those households below 80% countywide median income, the County and the Cities should develop coordinated strategies to disperse projected housing for those below 80% countywide median income throughout Kitsap County, where they are specifically found to be appropriate, in consideration of existing development patterns and densities.

 LUTAC members commented on the area median income (AMI) listed at 120% and questioned the origin of the number. Several LUTAC members suggested the AMI needs to be consistent with the introduction of the element.

AH-4. Provision of affordable housing for households below 80% countywide median income should include:

- LUTAC members suggested the draft policy add language regarding residential and commercial displacement. These LUTAC members suggested the policy language could better incorporate elements of VISION 2050.
- One LUTAC member suggested revising policy AH-4 A into two separate policies to focus on both UGAs and housing and rural areas.

Review of Element J: Community Economic Development

ED-1. A general strategy for enhancing economic development and employment:

• LUTAC members had no additional comments or feedback regarding this draft policy.

We look forward to the continued review of the Draft Countywide Planning Policy (CPP) revisions with the LUTAC on March 11th. In advance of the meeting, we have prepared a revised set of Draft CPPs for your consideration. The revised Draft includes changes resulting from comments received at the February 11 LUTAC meeting, written comments received, the February 17 LUTAC sub-committee meeting held in February, and additional conversations. In addition, changes to the Capital Facility and Transportation Elements has been inserted based upon comments received from TransTAC and TransPOL.

Revised CPPs

As directed by LUTAC during our sub-committee meeting, the draft policies have been arranged by policies that have been fully reviewed vs. those that need additional review. At the March 11th meeting, we will move as far forward as possible to review those polices that still need some attention. Outlined below are some general notes:

- Fully reviewed policies are marked with a check mark.
- There are a few policies where draft language was agreed on however, there are additional changes that have been proposed because of written comments. We will review those, and the comments note those policies.
- There are two new policies that might be of interest. Both came from comments at the last LUTAC and sub-committee meeting:
 - AH-5 that focuses on mitigating displacement that occurs when redevelopment takes place
 - ED-4 regarding providing appropriate and targeted economic growth in distressed areas with low and very low access to opportunity
- We have received comments from TransTAC and TransPOL on the Capital Facility and Transportation chapters. Those comments have been integrated in. You will also see that I have reworked the Capital Facility policies based on confusion caused by current terminology.
- No changes have been proposed yet for Element C. Karla will be presenting those proposed edits next week.
- Appendix C and G have been proposed for deletion based on comments received. We will review those at the March 11 meeting.

For any policies we do not get to next week, we will pick up at the sub-committee meeting being scheduled for later in March. If you have any questions, please contact me anytime.
