# **DEFINING AFFORDABILITY**

What does affordability really mean? What makes a house affordable, and why? What does it really cost to live in Washington today?

The Housing Needs Assessment describes factors that determine whether or not housing is affordable, to whom it is affordable and what places are more affordable than others.

### **Income Bands**

A number of terms are used consistently throughout this report to refer to specific housing concepts.

- » Housing costs: Homeownership costs include mortgage principal and interest, taxes, insurance and utilities. Rental costs include rent and utilities.
- » Affordability: Housing is affordable if a household pays 30 percent or less of their income for all housing costs.
- » Median family income: Incomes published by HUD for states, counties and large urban areas that are adjusted for household size. For Washington in 2012, this number was \$72,900 per year. for a fourperson household.
- » Area median income: Some analyses use the median income for a given geographic area as a reference point. This income is not adjusted for household size like the median family income, and so is usually a smaller number.

- » Extremely low-income: 30% or less of the median family income.
- » Very low-income: 30% to 50% of the median family income.
- » Low-income: 50% to 80% of the median family income. "Low-income" can also be used as a catch-all term for any household making 80 percent or less of the median family income.
- » *Moderate-income*: 80% to 100% of the median family income.
- » *Poverty:* The federal poverty threshold for a family of four in 2012 was \$23,050 per year. This was about 32 percent of Washington's median family income.

- » Cost burden: HUD defines any household paying more than 30 percent of household income on housing expenses as "cost-burdened." For example, a household earning \$100,000 per year but spending more than \$30,000 for housing is cost-burdened.
- » Severe cost burden: Any household paying more than 50 percent of household income on housing expenses.

#### 1. WELCOME AND INTRODUCTIONS

Chair Erickson welcomed participants to the meeting (see Attachment A: KRCC Board Members in Attendance, and Attachment B: Members of the Public in Attendance). All participants introduced themselves.

#### 2. FOUNDATIONS OF THE TASKFORCE WORK

The Taskforce discussed the draft norms and expectations, the draft meeting plan, and affordable housing terminology. Chair Erickson explained that the draft norms and expectations outline the purposes of the Taskforce, decision-making guidelines, meeting structure, and general media policy.

Chair Erickson reviewed the tentative 2019 Taskforce meeting schedule. She noted that three additional meetings will be held on the following dates: May 16, July 19, and September 18.

The Taskforce discussed affordable housing terminology based on U.S. Department of Housing and Urban Development (HUD) definitions. The affordable housing terminology will be used to guide the work of the Taskforce and determine which segments of the affordability spectrum the Taskforce will focus on. As part of this discussion Chair Erickson invited members of the public to share their thoughts about affordability. Their comments were as follows:

- C1: The HUD definition of affordability is defined in relation to area median income (AMI). Typically, 30% AMI is used when affordable housing units are being built.
- **C2:** The funding that can be provided for affordable housing by both the state and federal government is also connected to AMI definitions of affordability.



### 3. EXISTING CONDITIONS

Chair Erickson led the Taskforce through a review of affordable housing data, specific to Kitsap County. The data was compiled as part of the Washington State Housing Needs Assessment created by the Department of Commerce in 2015. The data includes information about affordable and available housing units for every 100 households, housing stock, cost burden for renter and homeowner households, and subsidized housing inventory. After reviewing the data, Taskforce members suggested the information could be used to explain the extent of housing needs in Kitsap County.

### 4. Affordable Housing Policy Tools

The Taskforce reviewed existing housing policy tools as described in the Housing Innovations Program (HIP). In addition to the housing policy tools, the Taskforce completed the draft policy tool matrix accounting for each of the jurisdictions. The affordable housing policy tool matrix was designed to determine which policy tools are currently in place, which policy tools have recently been recommended, which policy tools are in the process of being developed, and which policy tools could potentially be applied at a Countywide level.

The Taskforce discussed the policy tools and approaches to link them to affordable housing incentives and outcomes. Chair Erickson requested that the Taskforce complete a more detailed review of the affordable housing policy tool matrix for each respective jurisdiction. As part of the review, the Taskforce members were asked to complete a new matrix that covered the following:

- Confirm which policy tools your jurisdiction has.
- Discern which the policy tools can be tied to housing affordability.
- Estimate the number of affordable units produced through the application of a policy tool.

#### 5. EXPLORE POSSIBILITY OF AN EMERGENCY DECLARATION FOR AFFORDABLE HOUSING

KRCC Staff presented a summary of RCW 84.52.105, a copy of Jefferson County's State of Emergency, and a copy of the City of Bellingham's State of Emergency to guide the discussion about a potential emergency declaration for affordable housing. The Taskforce reviewed the emergency declaration resources and noted an emergency declaration was one potential avenue to secure funding for affordable housing.

Chair Erickson opened the conversation to all participants in the room to share their comments regarding ideas, concerns, and needs on affordable housing in Kitsap County. The following comments were made:

- **C1:** The 4-step process includes issuing a state of emergency; creating a financing plan; having a levy for affordable housing; and then a ballot initiative.
- **C2:** There needs to be more facts to explain the need before issuing a state of emergency.
- C3: There are nonprofit developers who build affordable housing and are not currently building in Kitsap County. It would be interesting to understand why they are not building in Kitsap County.
- C4: There must be a clear understanding of how much money is currently being spent on affordable housing before asking the public to support more spending on affordable housing.



- **C5:** The resolution is a statement of a need for affordability and is the first step. Following this step, funding from a property tax or a sales tax levy could be used.
- **C6:** The Taskforce needs to fully understand what the issues are and what the gaps are in the policies to support affordable housing.

### **6.TASKFORCE QUESTIONS, CONCERNS, AND ANNOUNCEMENTS**

Chair Erickson asked the Taskforce and members of the public to provide final comments about the discussion on affordable housing in Kitsap County. There were no further comments from the Taskforce and members of the public.

Chair Erickson suggested a panel of housing experts be arranged to discuss barriers and solutions to affordable housing with the Taskforce at the May 16 meeting. The Taskforce supported the idea of a panel at the next meeting. KRCC Staff will work to arrange a panel of housing experts for the May 16 AHTF meeting.

### 7. PUBLIC COMMENTS

Roger Gay stated that, as a taxpayer, there needs to be justification for increasing funding for affordable housing in Kitsap County.

Ed Stern stated that the first objective of economic development is business retention. One must take stock of what already exists in affordable housing. Therefore, it might be worth looking at what exists while planning for what will be.

#### 8. ADJOURN

The meeting adjourned at 12:15 p.m.
