A. WELCOME

Councilmember Ashby, City of Port Orchard, welcomed participants to the virtual meeting (see Attachment A for a list of TransPOL subgroup members and observers). She explained that the purpose of this subgroup meeting is to review issues that may come before the Kitsap delegation at the Puget Sound Regional Council (PSRC) Project Selection Task Force, Transportation Policy Board, and Executive Board.

B. Briefing on recent discussions regarding distribution of **CRRSAA** Act funds

Steffani Lillie, Kitsap Transit, explained the nine options being considered for allocating CRRSAA funds across Puget Sound transit agencies. The allocation method chosen may set a precedent for the allocation of future pandemic relief funds. Some transit authorities are advocating for certain options, and Kitsap Transit will not be negatively impacted by any of these options.

Kitsap Transit noted they were generally supportive of four options:

- Option 1: Earned Share Distribution
- Option 6: 2018 Operating Cap
- Option 8: Estimated Seattle UZA Increase from 75% Cap
- Option 9: Earned Share with Adjustment Based on Need

Ultimately, the subgroup recommended supporting Option 1: Earned Share Option, which is the same allocation process that has been used historically and is the most straight forward of the nine options.

C. REVIEW THE RATIONALE AND METHODOLOGY FOR THE KITSAP SET ASIDE

The subgroup discussed the rationale and methodology for the Kitsap Set Aside in the transportation funding competition. Kitsap County has maintained the set aside over the years and has a good relationship with the other Puget Sound counties but it is important to be prepared to justify the set aside if needed.

D. DISCUSS THE PROS/CONS OF THE TWO STREAMLINING PROPOSALS FROM THE KITSAP PERSPECTIVE

The group acknowledged that these two proposals were voted down at the PSRC Regional Project Evaluation Committee but that there may be interest at the Project Selection Task Force in discussing the items further. They made the following comments regarding the proposals.

- Proposal 1: Move all CMAQ funds to the Regional competition; all STP funds will be in the Countywide Competitions.
 - Kitsap can submit applications for up to six regional projects each cycle, and usually receives funding for one of these projects.

- With the exception of Kitsap Transit, Kitsap jurisdictions are not eligible for Congestion
 Mitigation and Air Quality (CMAQ) funds and therefore would not have the opportunity to put
 forward larger regional STP projects under this structure.
- o Kitsap would maintain its' position not in favor of this proposal.
- Proposal 2: Remove application limits in Regional Competition.
 - o Kitsap would maintain its' position not in favor of this proposal.

E. OTHER TRANSPORTATION-RELATED TOPICS SUGGESTED BY TRANSPOL SUBGROUP

The subgroup anticipates new proposals related to equity. Further discussion will be needed at PSRC on how equity is defined and how different definitions of equity will impact Kitsap's funding allocations. Mayor Erickson, City of Poulsbo, shared that she has been nominated for Vice Chair of the PSRC Executive Board.






