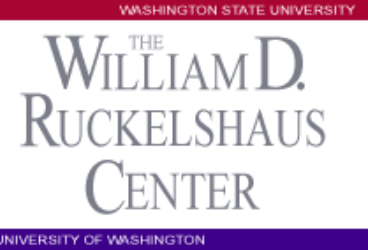




Road Map to Washington's Future



Project Purpose



2017-2019 Biennium Budget

Legislature allocated funds to the William D. Ruckelshaus Center to facilitate a two-year process to create a *“Road Map to Washington’s Future.”*

Purpose

- (1) To articulate a vision of Washington’s desired future
- (2) To identify additions, revisions, or clarifications to the **growth planning framework** needed to reach that future.

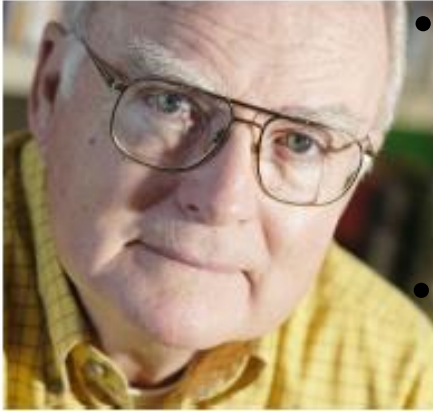

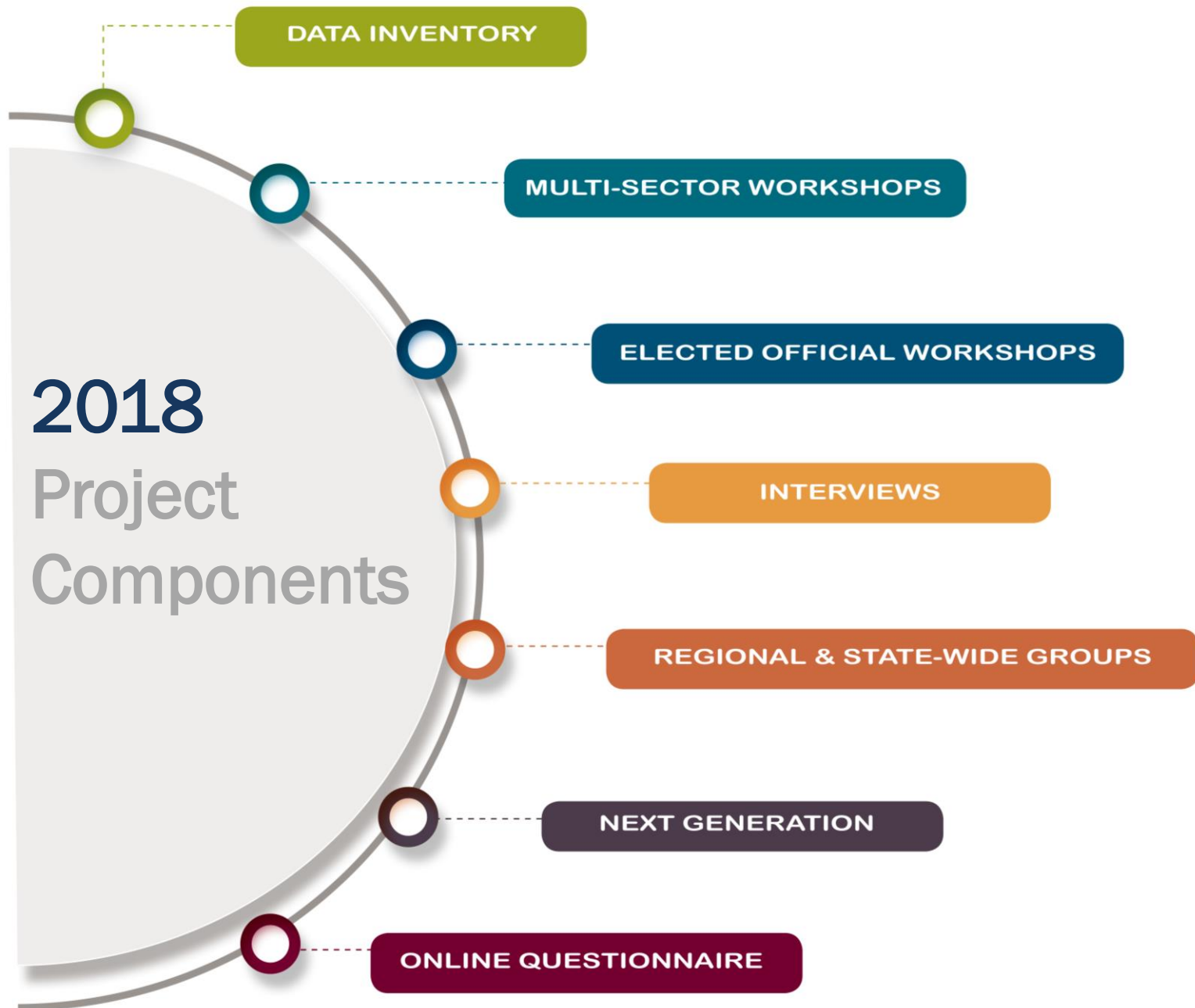
About the William D. Ruckelshaus Center



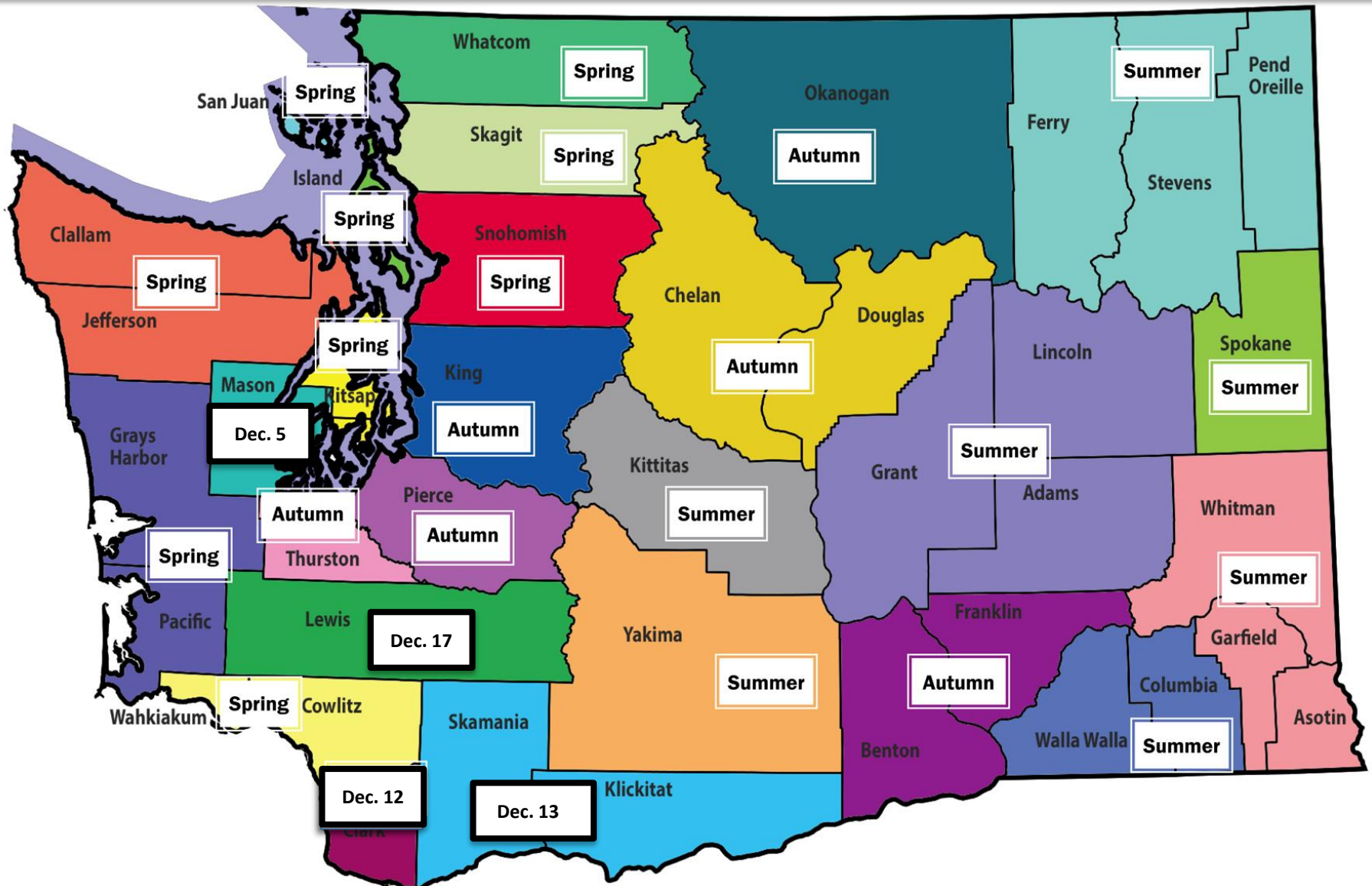
- The Center is named for founder and Advisory Board Chair William D. Ruckelshaus, devoted to his approach to collaborative problem solving.

- Potential paths to the desired future(s)

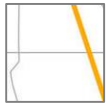

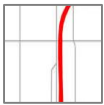
Potential paths to the desired future:

Share success stories and potential best practices



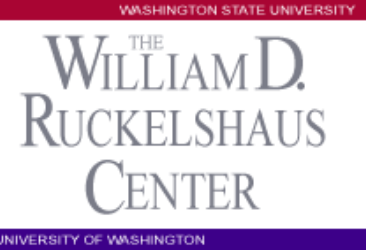
