1. Chair's Welcome

KRCC Chair/Kitsap County Commissioner Rob Gelder welcomed the Executive Committee to the virtual meeting.

2. Committee Updates and Action Items

A. Executive Committee Items

• Review the September 19 Executive Committee meeting summary

The September 19 Executive Committee meeting summary was approved by consensus.

Confirm virtual/hybrid formats for November public meetings

Members discussed the hybrid format used at the October 4 meetings for KRCC and other Kitsap Boards meetings at the Norm Dicks Government Center. The Committee decided to continue using the same hybrid format and health protocols for the next Board meeting while keeping an eye on future Covid levels and public health advice and adjusting protocols if circumstances change.

• Discuss 2023 KRCC Chair/Vice Chair for KRCC Board consideration

Historically, The KRCC Vice Chair assumes the Chair position the following year and a new Vice Chair is chosen. In recent years, one of the two Chair positions has been from the County and the other from one of the Cities, but this alternating pattern is not required by the KRCC Bylaws nor the Interlocal Agreement (ILA). Noting that there are many more members available from City member agencies than from the County who are eligible to serve as KRCC officers, the Committee discussed nominating a City official to serve as Vice Chair for 2023 with an eye toward nominating a County official as Vice Chair for 2024.

The Committee expressed confidence in Vice Chair Wheeler's ability to carry the responsibilities of the Chair in 2023. After discussing the balance of representation of various member jurisdictions over

the years and the capacity of members to take on the responsibility of Vice Chair in 2023, the Committee recommended nominating City of Bainbridge Island Mayor Joe Deets as Vice Chair for 2023.

 Review updates and discuss approval processes for drafts for 2023 KRCC work plan, budget, dues, and contract

The Committee discussed the proposed 2023 work plan, which is expected to be lighter than 2022 and looked beyond into 2024 when they expect a heavier workload. The committee recommended holding KRCC's total dues for 2023 level with the 2022 dues to allow for more steady budgeting and to continue to build up the financial capacity for anticipated higher expenses in 2024 and beyond. Members recommended letting the surplus continue to flow forward in the carryforward amount rather than adding it to the formal reserves, which are currently at a level that satisfies the 10% of budget in reserve that is recommended in KRCC's Policies and Procedures manual.

In order to equitably calculate dues for 2023, staff should use the 2022 dues total (\$243,000) distributed it among member agencies based on up-to-date population and assessed property valuation figures. The Committee also recommended that rather than stating a cap for only one year of the two- year contract, the wording should be changed in the proposed 2023-4 contract to state that "the total amount payable each year will not exceed the approved budget for that contract year."

• Discuss Legislative Reception updated proposal & questions

Staff updated the Executive Committee on Legislative Reception plans and RSVPs received so far. As of 10/19, four legislators: Senator Christine Rolfes (23rd District), Senator Randall (26th District), Representative Drew MacEwen (35th District), and Katy Crabtree (from U.S. Representative. Kilmer's office) have confirmed their participation on the panel and 15-20 Council members and Commissioners have registered. Many details and decisions for the event were discussed, including the following:

Food and beverages

- Chair Gelder will work with KRCC staff to finalize menu.
- Staff will arrange for a KRCC anniversary cake.

Payments and invoicing

- Payment for reception fee may be made by check, but not by cash on day of the event.
- Legislative Reception invoices from The Point should go to Chair Gelder at Kitsap County. He will work out logistics about after-event invoicing.
- Chair Gelder will confirm whether Lisa Fryer at Kitsap County is the correct person to receive the reception fee checks,
- Triangle will cover the payment for any balance due for the bar minimum the night of the event and will invoice KRCC.

Invitations

- Since the Legislative Reception is a working meeting, +1s will not be invited.
- Staff will extend invitations to specific lobbyists this week and to newly elected officials after election results are known.
- Due to venue capacity issues, the Gorst Coalition members who do not have another role with KRCC will not be invited.

• Members will reach out and encourage their legislators and their fellow council members and commissioners to attend.

Event agenda and other details

- AWC and WSAC will have time in the agenda to present legislative priorities.
- Members will contribute topics/questions for panel discussion to Chair Gelder by the end of the week.
- Chair Gelder will work with KRCC staff to develop panel questions,

 - o Ferry service and ferry funding
 - Health care
 - Transportation
 - o Addressing these topics with the lens/theme of cooperation
- Discuss idea of KRCC newsletter for briefing councils and commissions

The idea of creating a newsletter to keep councils and commissions apprised of KRCC related updates was discussed. The Executive Committee decided not to pursue the idea further, thinking a newsletter would not be an effective use of staff time.

B. Land Use Items

The Committee reviewed the draft November 10 LUTAC meeting agenda and made no changes.

C. Transportation Items

TransPOL met on October 20 in the afternoon. There were no significant outcomes from this meeting.

Discuss efforts to reengage Tribes

Chair Gelder reached out to Chairman Forsman to check in about the 2008 Memorandum of Understanding (MOU) between KRCC and the Tribes. The MOU might never have been signed. Port Gamble S'Klallam Tribe are the venue hosts for the Legislative Reception. Members noted that Tribal staff have sometimes been more available to participate than Tribal leaders, and that any ongoing Tribal participation in KRCC would be highly valued.

The Committee approve September 2022 invoice of \$11,172.57 by consensus.
