1. Chair's Welcome

KRCC Vice Chair/Bremerton Mayor Greg Wheeler welcomed the Executive Committee to the virtual meeting.

2. Committee Updates and Action Items

A. Executive Committee Items

Review the April 21 Executive Committee meeting summary

By general consensus, the April 21 meeting summary was approved as written.

• Updates to state requirements and recommendations regarding remote and hybrid public meetings

The Committee discussed changing guidance and requirements for public meetings. New rules effective June 1 per the WA state Open Public Meetings Act include:

- Meetings are no longer required to be held remotely.
- Telephone/video access to public meetings is no longer required but is still strongly recommended.
- "When feasible," public meetings should include a physical location where the public can
 attend the meeting. If a public meeting is being held virtually, this can be a room where a
 livestream of a remote meeting is presented for public viewing.
- Meetings may remain fully remote and/or limit physical participation if an agency determines that an in-person meeting cannot occur with "reasonable safety" due to declared local state or federal emergency. (Washington state is still in a declared state of emergency.)
- Where there is no state of emergency, members of the governing body may still attend public meetings remotely.

Members discussed their desires to stay remote through June due to Covid numbers in the County and how to offer an in-person option for public attendance at June public meetings. Staff updated members on developing plans shared by other Kitsap Boards who meet on the 1st Tuesdays of the month. Members shared their jurisdictions' recent progress toward starting to meet in person again.

KRCC has no public meetings scheduled in July or August and would like to start holding hybrid meetings in September, beginning with the KRCC Board meeting on September 6. Between now and September, KRCC staff will arrange for training on the equipment at the Norm Dicks Center to be ready to support KRCC's future hybrid public meetings. The Committee advised KRCC staff to seek guidance from Kitsap Health District and to coordinate with the other Boards who meet on the first Tuesdays of the month in chambers at the Norm Dicks Government Center so that there can be one common set of Covid protocols recommended by the Kitsap Health District for the several meetings members need to attend that day.

The Executive Committee decided that KRCC would keep to the plan they outlined in April for the transition to hybrid meetings.

Through June 2022

- All KRCC meetings will remain remote.
- June public meetings will be livestreamed at the Norm Dicks Government Center to provide an option for public to attend in person.

After June 2022 (subject to revision based on public health circumstances)

- KRCC public meetings become hybrid (Executive Board, PlanPOL, TransPOL).
 - With an in-person component at the Norm Dicks Center and a simultaneous virtual option offered via Zoom webinar
 - o Members will be encouraged to attend in person but may attend virtually if needed
 - Public can attend virtually or in person according to individual preferences
- Any KRCC committee meetings that are not public meetings will remain fully remote via Zoom for the rest of 2022. (Executive Committee, TransTAC, LUTAC).

B. Land Use Items

Review draft June 9 LUTAC meeting agenda

On May 12, LUTAC discussed the draft growth targets and feedback from PSRC staff. They made one update and then agreed to recommend the draft targets to PlanPOL. During the May 17 PlanPOL meeting, PlanPOL reviewed the draft targets along with documentation of PSRC's review. KRCC Board will review the growth targets at the June 7 Board meeting. On June 9, LUTAC will discuss any adjustments to draft growth targets based on the Board's feedback.

• <u>Information: staff response to follow up questions re: growth targets and the City of Bainbridge Island's Countywide Growth Center</u>

Mayor Deets updated the Committee on discussions with Bainbridge City Council Members and City staff about these topics and confirmed the matter has been concluded.

C. Transportation Items

Review Letter from KRCC to Kitsap Legislators re: Move Ahead WA

Committee members reviewed a letter drafted at the suggestion of TransPOL and the Executive Committee to express appreciation to Kitsap Legislators that voted for Move Ahead Washington transportation funding package and to express KRCC's support for continued transportation funding from state and federal sources. Members offered edits to the letter including signatures for the letter and the addition of a sentence noting that the scale of investment in the ferry system was truly appreciated.

Review draft May 31 TransTAC meeting agenda

May 31 meeting is an all-day workshop where TransTAC will be developing their recommendations for Countywide processes for TransPOL to review on June 2. This meeting was planned to be hosted at the airport conference room. (*Update: due to concern about potential inequities with some participants attending in person and others participating online, this meeting was later changed to be a remote meeting for all participants.*)

Review draft June 2 TransPOL meeting agenda

TransPOL is not meeting on its usual schedule on May 19. That meeting was shifted to June 2 to accommodate the transportation competition schedule. This meeting will be remote via Zoom

1. Chair's Welcome

KRCC Chair/Kitsap County Commissioner Rob Gelder welcomed the KRCC Executive Committee to the virtual meeting.

2. Committee Updates and Action Items

A. Executive Committee Items

Review the May 19 Executive Committee meeting summary

The May 19 Executive Committee meeting summary was approved by consensus as drafted.

Review update on Kitsap Boards' remote/in-person meeting plans

Executive Committee members expressed a preference for Kitsap Boards to coordinate meetings so the meetings that occur on the first Tuesday of the month have the same format (in-person vs. virtual). The Executive Committee will revisit the fall hybrid meeting plan based on updated circumstances at the end of the summer.

1 – Approved Exec. Committee 6/16/22 Meeting Summary

• <u>Discuss KRCC's 30th anniversary and possibilities for celebration</u>

KRCC was established in 1992, making 2022 the 30th anniversary of the organization. Members discussed ideas for celebrating the anniversary at the Legislative Reception, revising the KRCC logo, and/or using a collaborative video-making app to create a series of short videos about what makes Kitsap collaboration special. Members supported the idea of adding the phrase "Celebrating 30 years of regional cooperation" to the letterhead/agenda headers effective immediately. Logo suggestions included:

- Change the color
- Be more inclusive "Cities, Counties, Tribes" leaves out Navy, Transit, and Ports
- Do not add too many words. Keep the logo simple and graphic.
- Who might design a new KRCC logo?
 - Hold a community contest for ideas
 - Commission a native artist
 - Hire a graphic design firm

B. Land Use Items

Upcoming meetings

PlanPOL is scheduled to meet September 20. LUTAC is scheduled to meet on October 13. The KRCC Executive Committee will review draft agendas for these meetings later this summer.

Process for Kitsap County adopting the Countywide Planning Policies with the updated growth targets

On June 28, the Board will vote on approving the updated growth targets as an appendix to the Countywide Planning Policies (CPPs). If approved, the appendix will then be transmitted to Dana Daniels, Clerk of the Board, with CC to Commissioner Wolfe and Eric Baker.

Members discussed the growth targets' relationship to the next steps of jurisdictions' comprehensive plan updates, recognizing that growth targets were designed with room to adapt and allocate population between cities and their adjacent urban growth areas (UGAs) as comprehensive plan details are worked out. To clarify some of this flexibility, planners have added the footnote "During a Comprehensive Plan review process, a city and its associated UGA may transfer population and employment between the two jurisdictions with approval by elected bodies from both jurisdictions, while not exceeding the overall targets."

C. Transportation Items

• Debrief of the Countywide Competition for federal transportation funds

Members noted their appreciation for a collegial and collaborative process for the transportation funding competition.

4. Administrative Agenda

Review Corrections to Income and Expense report from 2021 Audit

Staff reported that minor corrections were made to the Income and Expense report during the 2021 Financial Audit. A corrected Excel formula error in the August 2021 invoice amount resulted in an increase in the amount of carryforward from 2021 to 2022. Corrected formulas in the 2022 spreadsheet relating to which expenses are paid via Triangle and which are paid separately resulted in no changes to amounts previously reported to the Board.

Approve Triangle Associates May 2022 Invoice

The motion to approve the May 2022 invoice of \$21,229.36 passed without objection or abstention.

<u>Discuss encouraging Tribes' participation in KRCC</u>

Members discussed the importance of having the Suquamish Tribe's and Port Gamble S'Klallam Tribes' participation in KRCC. KRCC staff will hold an orientation session with staff from the Port Gamble S'Klallam Tribe on June 16. Chair Gelder has reached out to Chairman Sullivan. As of the end of May, dues payments for 2022 have not been received from the Port Gamble S'Klallam Tribe nor from the Suquamish Tribe. Chair Gelder will reach out to leadership from the Suquamish Tribe and Port Gamble S'Klallam Tribe to understand their goals for KRCC membership.

Updates on upcoming KRCC meetings

KRCC Board meeting will shift from September 6 to October 4. The Executive Committee will not meet in July or August. Invoices, September meeting agendas, and other essential administrative business will be approved via email over the summer. The September Executive Committee meeting will include review of the Draft 2023 KRCC Work Plan.

5. Good of the Order

Jurisdictions will be developing their housing targets independently and then compiling and discussing them together. Johnson Road Roundabout will be opening soon. Poulsbo is organizing a grand opening ceremony and plans to invite the Governor. Members also discussed last month's Transit Center groundbreaking event.
